לבקשתך חוות דעת ראשונית על פגיעתו של עצור מספר

פצוע פונה משרה תימן לביה"ח אסותא אשדוד בתאריך 6/7/24.

על פי בדיקתו הראשונית, חבלה בצוואר, חזה וכן דם רקטלי. אין כל ציון לפגיעה בפי הטבעת עצמו בזמן הגעתו.

לאחר בדיקה ראשונית וטיפול בפגיעת החזה, הועבר לבצוע בדיקת סיטי. במסגרת בדיקה זו, אף הוחדר חומר ניגוד לחלחולת (כמובן, דרך פי הטבעת). גם בפעולה זו, לא מתואר קושי או שום בעיה חריגה בפי הטבעת.

בהמשך, נותח החולה (בסיטי עדות לקרע בחלחולת (רקטום)). בזמן הניתוח, שוב בוצעה בדיקה ידנית דרך פי הטבעת וגם אז, אין כל תאור של פגיעה בפי הטבעת עצמו.

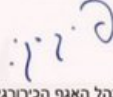
מכיוון והייתה פגיעה בחלחולת, אין ספק כי החדרת גוף זר, היא שגרמה לפגיעה. אולם, יש ספק גדול לגבי דרך ומנגנון החדרת הגוף הזר, שגרם לפגיעה בחלחולת.

החדרה על ידי גורם חיצוני, ודאי של עצם רחב (כדוגמת אלה או מקל של מטאטא) מחייבת פגיעה של פי הטבעת עצמו (בנוסף לפגיעה בחלחולת) וסימנים ברורים לפגיעה זו. דווקא החדרה עצמית של גוף זר, שיכולה באותה מידה לגרום לקרע בחלחולת, היא שלא תגרום לפגיעה בפי הטבעת עצמו, שכן המחדיר (החולה עצמו) ידאג להחדרה עדינה ולא טראומטית של הגוף הזר.

החומר הרפואי, שהוצג לי (מסמכי אשפוז וכן צילום מסך מחשב מיום 8/7/24 של ד"ר מוחמד מילחם) בלא כל עדות לפגיעה בפי הטבעת, תומך בהחדרה עצמית ולא בהחדרה על ידי גורם חיצוני.

At your request, a preliminary opinion on the injury of detainee number

A wounded man was evacuated from **Sde Teiman** to Assuta Ashdod Hospital on 7/6/24.

According to his initial examination, injury to the neck, chest and rectal bleeding. There is no indication of damage to the anus itself at the time of his arrival.

After an initial examination and treatment of the chest injury, he was transferred to perform a CT scan. As part of this test, a contrast material was also injected into the **rectum** (of course, through the anus). Even in this **examination**, no difficulty or any **abnormality** is described in the anus.

Later, the patient was operated on (with evidence of a rupture in the rectum). During the surgery, a manual examination was again performed through the anus and even then, there is no description of injury to the anus itself.

Since there was an injury to the **rectum**, there is no doubt that it was the insertion of a **foreign object** that caused the injury. However, there is great doubt about the way and the mechanism of the insertion of the **foreign object** which caused the injury to the **rectum**.

Insertion by an external factor, certainly of a **wide object** (such as **an iron bar** or a broom stick) requires injury to the anus itself (in addition to injury to the **rectum**) and clear signs of this injury. It is precisely the self-insertion of a foreign body, which can equally cause a rupture in the **rectum** that will not cause damage to the anus itself, since the inserter (the patient himself) will ensure a gentle and non-traumatic insertion of the foreign **object**.

The medical material, which was shown to me (hospitalization documents as well as a computer screen shot from 8/7/24 of Dr. Muhammad Miam) without any evidence of injury to the anus, supports **self-insertion** and not insertion by an external party.

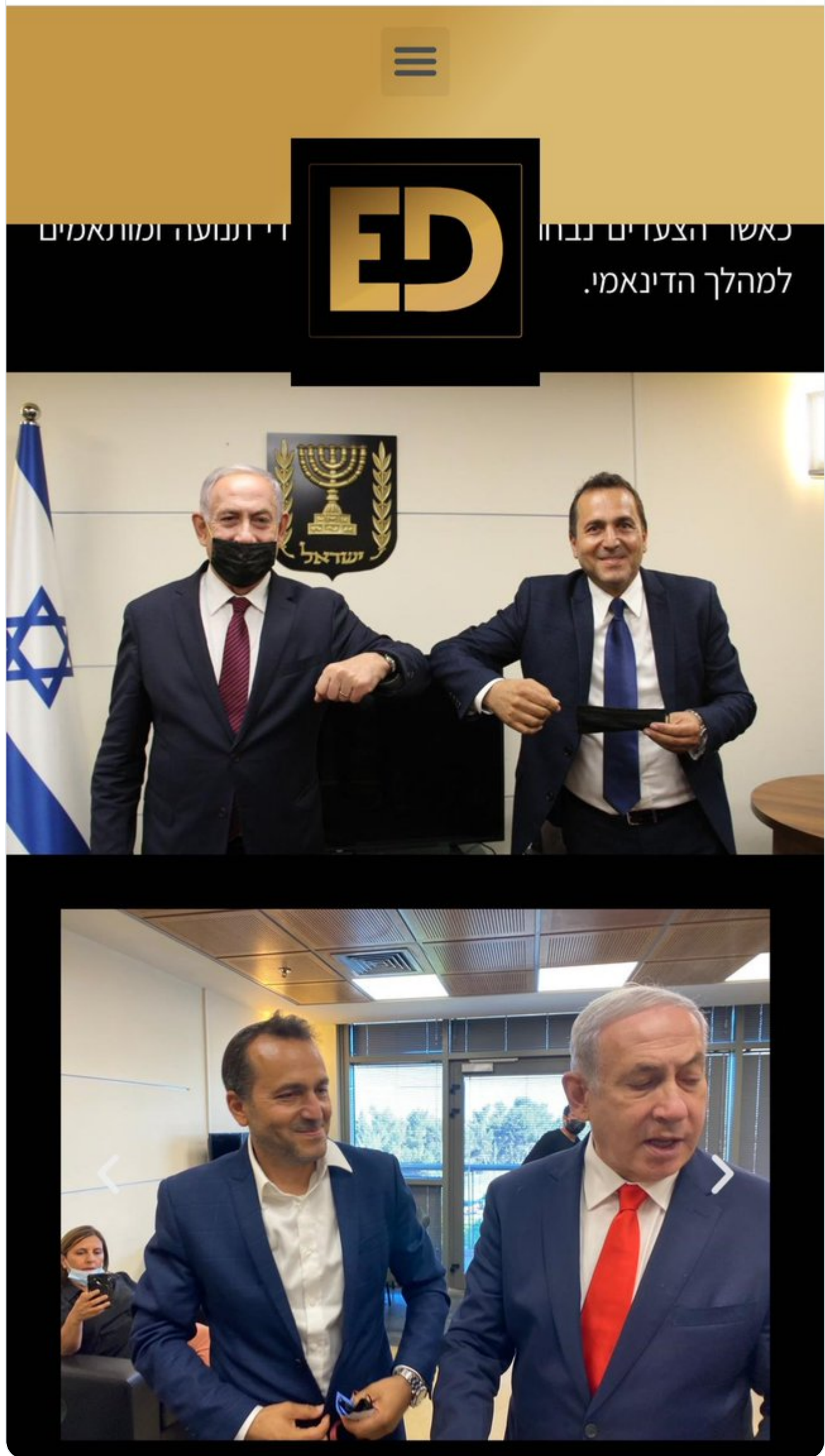

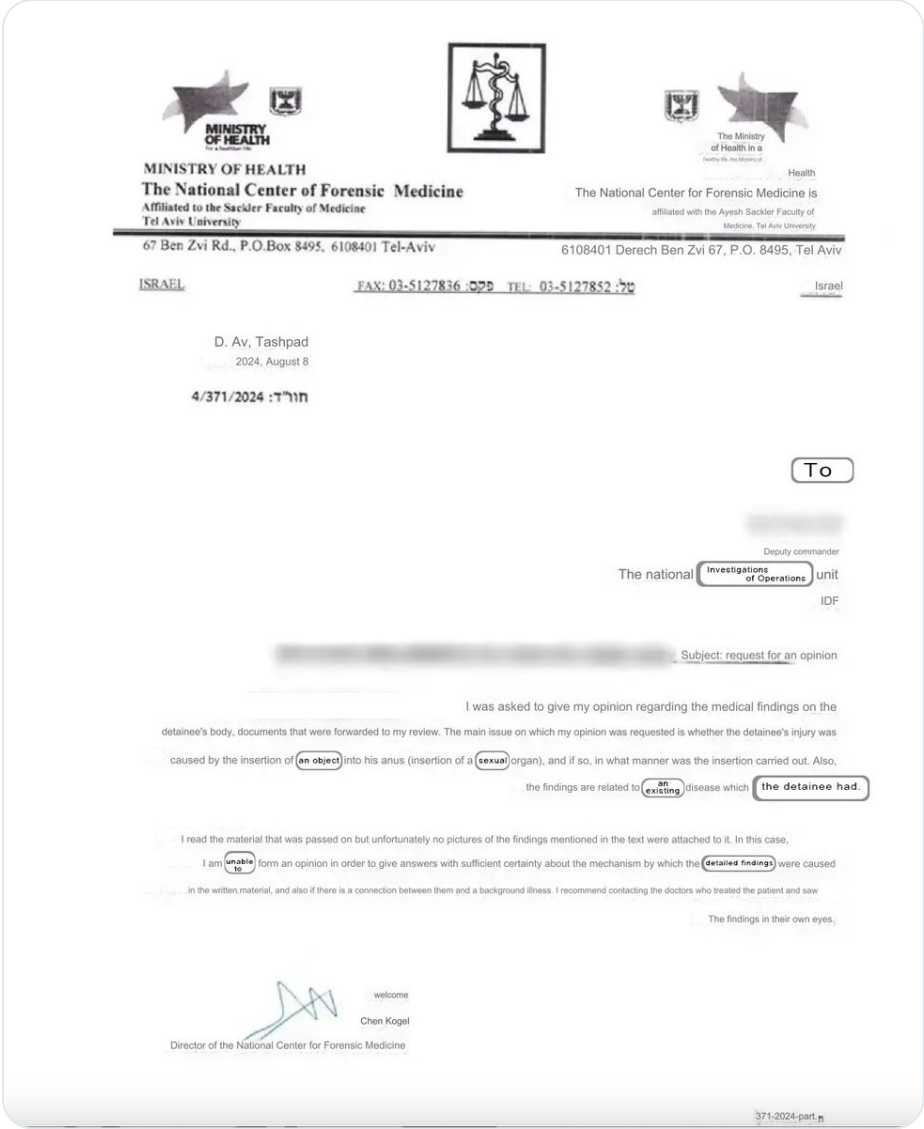

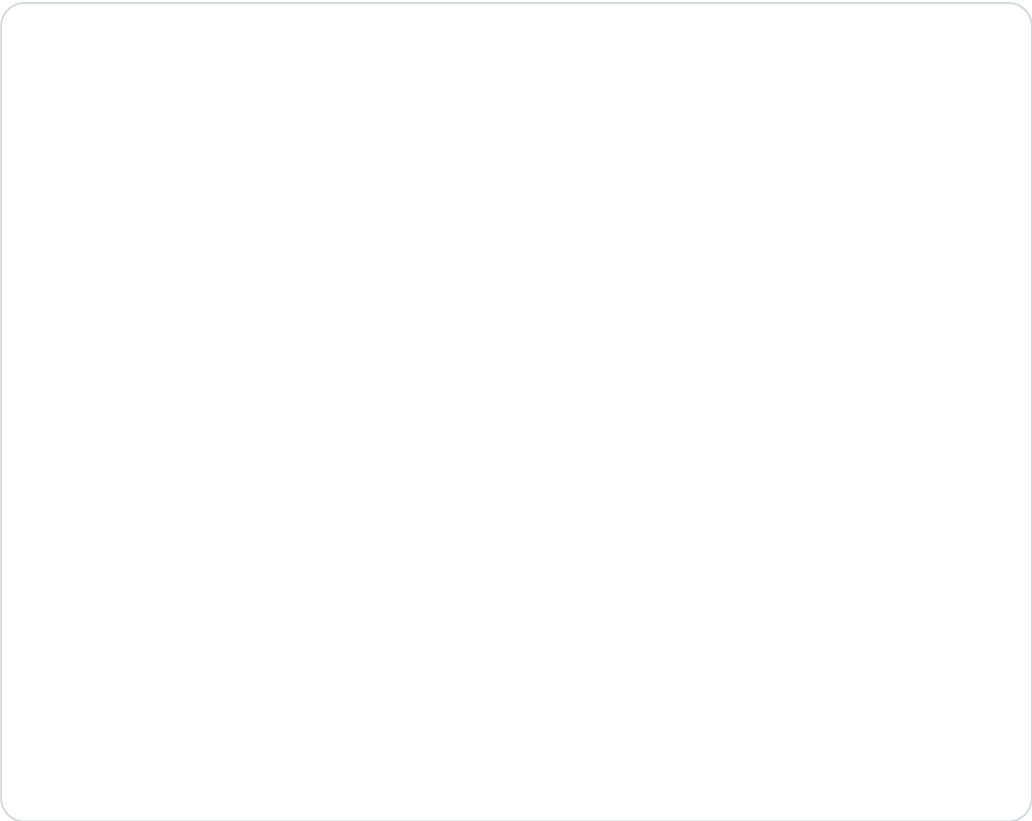

According to the prosecutor, three of the soldiers, including two reservists and their commander, approached the sleeping prisoner, woke him up and pinned him to a wall.

After the prisoner fell to the ground, one of the suspects was joined by other soldiers and beat the prisoner with a club for 15 minutes. They dragged him along the floor and electrocuted him with a taser, the court was told.

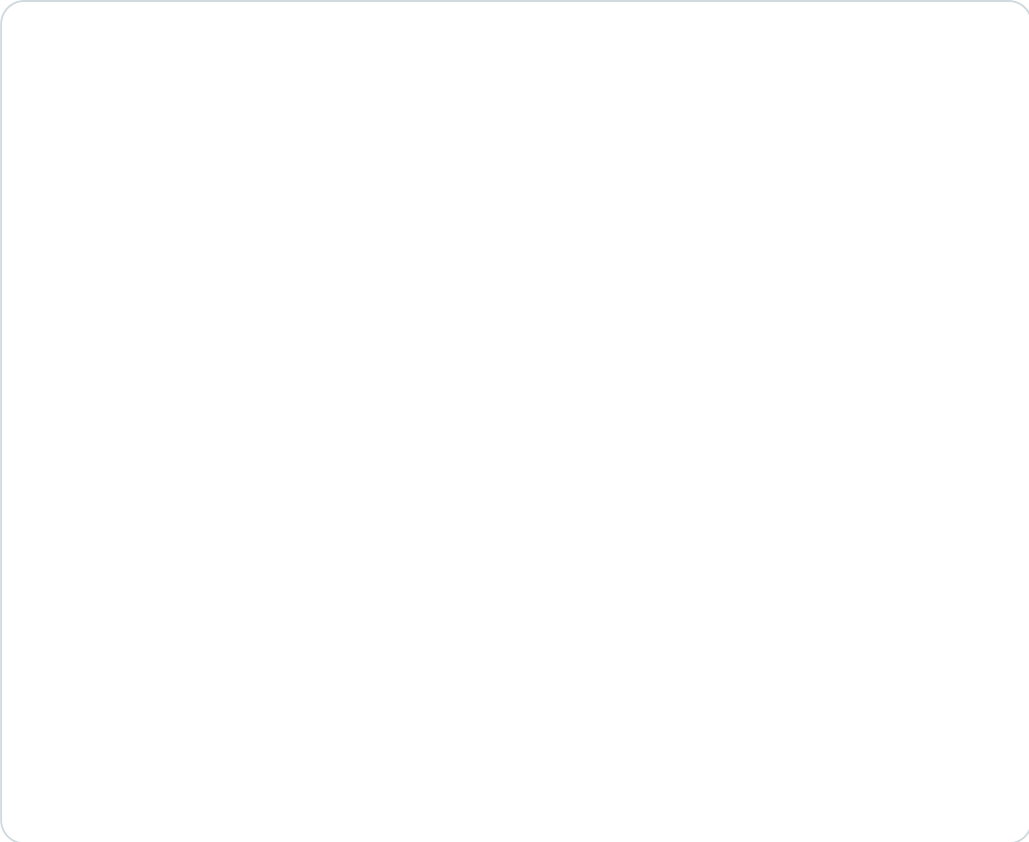
